Candidate filing for the General Election to be held November 3, 2020 begins on July 13, 2020. Every general election, dozens of people are appointed to local district boards because there are not enough people who file for office. If you would like to have a say in what happens to your community, filing for office is the perfect opportunity to do so.

The deadline to file is 5 PM on Friday, August 7, 2020 (or August 12, 2020 if an incumbent does not file) for local offices. Due to the heightened necessity for social distancing during the COVID-19 pandemic, the Placer County Registrar of Voters is offering and encouraging no-contact candidate filing for the November 3, 2020 General Election. As such, you may access your Candidate Filing Packet on our website or request to have one emailed or mailed to you by contacting our office. We are asking candidates to make an appointment to submit their completed filing paperwork by visiting our website, or submitting a request by email, or phone. If you are filing for any of the City or Township offices please file with the appropriate City or Town Clerk in your jurisdiction, otherwise the completed candidate filing paperwork will be submitted to the Elections Office located at 2956 Richardson Drive in Auburn, Monday through Friday, 8:00 AM to 5:00 PM.

All candidate filing documents with <u>original signatures</u> must be received in our office on or before the close of candidate filing, whether by mail or in person to be included on the ballot for the November 3, 2020 General Election. Placer County residents in the Tahoe area will also be able to file at the Placer County Assessor's Office located at 775 North Lake Blvd, Tahoe City. Candidates can file for office here August 4, 2020 through August 6, 2020 from 11:00 AM through 3:30 PM by appointment only. If you are unable to file in Tahoe City on those dates you may file at the Auburn office during regular business hours throughout the filing period. The Assessor's Office in Tahoe will also be available August 11, 2020 and August 12, 2020 from 11:00 AM through 3:30 PM if there are any offices with an extended filing period in the Tahoe area.
